WARRANTY CARD

This Warranty against defects for your newly purchased Blueair product is proudly prepared by Arisit PTY LTD

Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.

Where your product was purchased in New Zealand, the Consumer Guarantees Act (CGA), extends to you the right to have defective products (that are capable of repair in a reasonable time) repaired with a new or equivalent current model free of charge, or repair the product at our cost, but such method of repair will be at our election. Where the defect is substantial and can't be repaired in a reasonable time, you may be entitled to a refund or replacement of current or equivalent model free of charge.

AUSTRALIA & NEW ZEALAND (SUBJECT TO ANY RIGHTS YOU HAVE UNDER THE ACL OR CGA REFERRED TO IN POINT 1)

WITHIN FIRST 30 DAYS OF PURCHASE

Within the first 30 days of purchase Arisit may replace the defective unit at no charge. Operational and cosmetic expectations are not considered a defect and will not be subject to a replacement.

30 DAYS AFTER PURCHASE:

After 30 days, ARISIT's obligation and liability under the warranty may be limited to repairing or replacing the defective unit and paying the return freight..

1. Subject to your Statutory rights, ARISIT will during the warranty term provide a replacement of an equivalent current model where the balance of the warranty period from the original date of purchase will take effect or the product may be repaired with the use of new or refurbished replacement parts.
2. To the fullest extent permitted by law and subject always to your Statutory rights, ARISIT will not be liable for:
 - a. any loss or damage arising from loss of use, loss of profits or revenue; or
 - b. for any indirect or consequential loss or damage resulting from any breach of this warranty against defects.
3. Subject to your Statutory rights, defective ARISIT products may be replaced by a refurbished product of the same type or the product may be repaired with the use of new or refurbished replacement parts.

LIMITATIONS TO YOUR ARISIT WARRANTY

4. Subject to Point 1, this Warranty:
 - a. will only be provided to the original purchaser where the original purchase was made from an ARISIT Authorised Dealer or Reseller and proof of such purchase can be presented at the time of service;
 - b. will not apply where the defect in or failure of the product is attributable to misuse, abuse, accident or non-observation of the manufacturer's instructions. This product must be used in accordance with the manufacturer's instructions;
 - c. will not apply if the filters are not replaced as per recommended filter lifetime with the manufacturers original equipment type purchased from ARISIT or its authorised dealers
 - d. does not cover the cost of repairs carried out by non-authorized repairers or the cost of correcting such unauthorised repairs.
 - e. does not cover normal recommended maintenance as set out in the manufacturer's instructions;
 - f. does not cover repairs when the appliance has been dismantled, repaired or serviced by other than an authorised repairer or the selling dealer;

g. will not cover faults due to normal wear and tear with reasonable use nor consumable components such as filters.

h. does not cover extreme or external causes beyond our reasonable control including, but not limited to, breakdowns, fluctuations, or interruptions in electric power, ISP (internet service provider) service, wireless networks, or Bluetooth® connectivity issues, weak and/or inconsistent wireless signal strength in your home; or

i. is void in the event the serial number or part thereof has been removed or defaced.

IMPORTANT: If filters are not changed as per recommended filter lifetime, the effectiveness of the unit will decline progressively to a point at which the fan is subjected to a level of stress for which it was not designed. In such circumstances the warranty will be deemed invalid.
